Sub:-Electricity – Reformatting the Original Test Report (OTR) – Instruction issued - Reg

Ref:- CMD/TANGEDCO's Note approval dated 22-12-2020 in FLM-CM/323/2020 \*\*\*\*\*\*\*

In continuation to the introduction of online application filing for all categories of service connections except hut and agriculture, it is decided to reformat the Test Report under ease of doing business (EoDB) so as to simplify the process of effecting service connections to the applicants. As per the simplified format, Test Report has the following forms:

- a. Self Declaration Form The format is enclosed in Annexure-I. The applicant of the service connection has to furnish the duly filled-in form while applying for new service connection through online. The Aadhar based sign in facility shall be made available for signing this form by the applicant. There shall be additional options to download, sign, scan and upload the documents and the consumers who do not have printer to take printout, have the option to scan their signature and upload.
- b. Test Certificate Form The format is enclosed in Annexure-II. This form has to be filled by the Licensed Electrical contractor having valid license issued by Licensing Authority, Government of Tamil Nadu. The Test Certificate form has to be kept with the applicant permanently and the same has to be produced as and when required by the Licensee at any stage.
- c. **Service Report Form** The format is enclosed in Annexure-III. This form has to be filled by the section officer concerned in the Application Tracking Software while effecting service connections. The filled-in details by the TANGEDCO official shall be made available as downloadable form to the consumer concerned as per the provision in the Regulation 31(1) of the TNE Distribution Code.
- 2. The Self Declaration and the Test Certificate Forms shall be made available in the website as downloadable form (online application filing software) for filling the required details by the applicant and the licensed electrical contractor respectively.

- 3. The existing practice of sending the Test Report Forms to the Revenue branch through AEE concerned need not be followed since the forms viz. Self Declaration and Service Report can be viewed online by all the officials concerned to crosscheck the details of the service connection, payments made by the consumers, etc.
- 4. The above instructions shall be scrupulously followed by all the field officials of the TANGEDCO without any deviation.
